1. What we need

Our Personal Data Protection Policy governs the use and storage of your data. You can see our Personal Data Protection Policy at www.sacaeurope.com

SACA EUROPE SP. Z O.O. is a Controller of the personal data you (data subject) provide us. We collect the following types of personal data from you:

- Names
- E-mail addresses
- Titles
- Phone Numbers
- Addresses
- Gender and nationality
- Cookies and usage data*

** This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.*

When you access the website with a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data

2. Why we need it

We need your personal data in order to provide you with the following services:

- Collection of email addresses for purpose of emailing special offers
- Collection of postal addresses in order to deliver the goods
- Maintaining and promotion of SACA EUROPE SP. Z O.O. business relationships and answering enquiries and/or questions for clients or manufacturers
- To provide recruitment and related services to/for you and to facilitate the recruitment process
- To contact you with newsletters, marketing or promotional materials and other information that may be of interest to you
- To provide customer support
- To detect, prevent and address technical issues

3. What we do with it

Your personal data is processed in SACA EUROPE SP. Z O.O.'s office located in Poland. The personal data SACA EUROPE SP. Z O.O. collects from you is stored in one or more databases hosted by third parties. These third parties do not use or have access to your personal data for any purposes other than storage and retrieval.

4. How long we keep it

Under [Poland] law, we are required to keep your documents for [10 years] according to the Data Retention Policy. After this period, your personal data will be irreversibly destroyed. Any personal data held by us for marketing and service update notifications will be kept by us until such time that you notify us that you no longer wish to receive this information.
